This template can be used for multiple purposes:

- It enables schools to effectively plan their use of the Primary PE and sport premium
- It helps schools to meet the requirements (as set out in guidance) to publish information on their Primary PE and sport premium
- It will be an effective document to support Ofsted inspections enabling schools to evidence progress in Physical Education (PE) and evidence swimming attainment, which forms part of the PE National Curriculum. We would recommend schools consider the Intent, Implementation and Impact of any spend, as examined within the Education Inspection Framework.

It is important that your grant is used effectively and based on school need.

Schools must use the funding to make **additional and sustainable improvements** to the quality of the PE, School Sport and Physical Activity (PESSPA) they offer. This means that you should use the Primary PE and sport premium to:

- Build capacity and capability within the school to ensure that improvements made now will benefit pupils joining the school in future years
- Develop or add to the PESSPA activities that your school already offers.

**The Primary PE and sport premium should not be used to fund capital spend projects; the school's core budget should fund these. Further detail on capital expenditure can be found in the updated [Primary PE and sport premium guidance](#).**

The Primary PE and sport premium guidance, outlines 5 key priorities that funding should be used towards. It is not



necessary that spending has to meet all the key priorities, you should select the priorities that you aim to use any funding towards.

Although completing this template is not a requirement for schools, schools are required to publish details of how they spend this funding. Schools must also outline what the impact this funding has had on pupils' PE and sport participation and attainment and how any spending will be sustainable in the future. **All funding must be spent by 31st July 2024.**

The Department for Education has worked closely with the Association for Physical Education (afPE) and the Youth Sport Trust (YST) to develop this template and encourages schools to use it. ## Review of last year's spend and key achievements (2022/2023)

We recommend you start by reflecting on the impact of current provision and reviewing your previous spend.

<p>A Specialist PE Teacher was employed for the year. She taught the Primary School PE National Curriculum from Yrs 1 to Y6 as well as the Reception Class.</p> <p>On top of this she led additional PE sessions as part of structured play at lunchtimes (Alongside our Sports Leaders) and also delivered an extensive after-school programme at the end of the school day.</p> <p>Give all children access to a variety of sports after school which they otherwise wouldn't access as part of their daily routines. Lots of these activities will build upon their prior learning from PE National Curriculum.</p>	<p>High quality PE lessons being taught across the school plus an extensive extra-curricular provision which engaged the children and developed their interest in sport.</p> <p>On average, 60 children per week accessed an after school sports activity over the year.</p> <p>All activities were oversubscribed so they have been run on 6 week rotas so all children, if they want to, have had access to the clubs.</p>	<p><i>The full Sports Premium funding was used to pay for the Specialist PE teacher. As you can see from the comments below the impact of this was very positive across the school.</i></p> <p>Children have received high quality PE lessons from a Specialist PE teacher while staff have been able to access very good CPD at first hand through their joint participation and observation of the lessons.</p> <p>This was a big success and had a very positive impact on children throughout the school.</p>

Review the PE curriculums long and medium plans as well as the progression grids to ensure that prior learning/knowledge is built upon year on year. <i>(This has been done in line with the Complete PE Scheme of Work)</i>	- The PE Curriculum is progressive. - All staff have a clear understanding of the units being taught and how it builds on prior learning. - Children are taught a variety of skills throughout the year groups.	- The long and medium term plans have clear objectives which build upon prior learning. *Priority should always be given to ensuring that pupils can perform safe self-rescue even if they do not fully meet the first two requirements of the National Curriculum programme of study*

What percentage of your current Year 6 cohort can swim competently, confidently and proficiently over a distance of at least 25 metres?	<b>77%</b>	The negative impact of COVID is still being felt by the older children in the school due to the closure of leisure centres and swimming pools. Children were unable to access them in their more formative years and this has had a negative impact higher up the school resulting in greater numbers of pupils who lack confidence in the water.
What percentage of your current Year 6 cohort can use a range of strokes effectively [for example, front crawl, backstroke, and breaststroke]?	<b>10m front and back only – 81%</b>  <b>25m front and back only – 48%</b>  <b>25m front back and breaststroke – 0%</b>	These figures relate directly to the statement above and the increasing numbers of children, compared to pre-covid, who feel less confident in the water and who aren't yet proficient swimmers.
What percentage of your current Year 6 cohort are able to perform safe self-rescue in different water-based situations?	<b>90%</b>	Despite the lower numbers who are able to perform specific strokes it has been pleasing to see the increasing numbers of children who are able to perform self-rescue.

<p>If your schools swimming data is below national expectation, you can choose to use the Primary PE and sport premium to provide additional top-up sessions for those pupils that did not meet National Curriculum requirements after the completion of core lessons. Have you done this?</p>	<p><b>tbc</b></p>	<p>As mentioned earlier the school will hopefully be targeting those y6 children, who need top-up sessions, over the summer term (2024). This will be dependent on the timetabling of sessions from the Local Authority and availability of swimming sessions</p>
<p>Have you provided CPD to improve the knowledge and confidence of staff to be able to teach swimming and water safety?</p>	<p><b>tbc</b></p>	<p>As part of the SLA with the Local Authority a specialist swimming teacher delivers the swimming sessions to all year groups. However it is our intention to identify additional training for the PE Lead in school.</p>
